INDUSTRY OVERVIEW

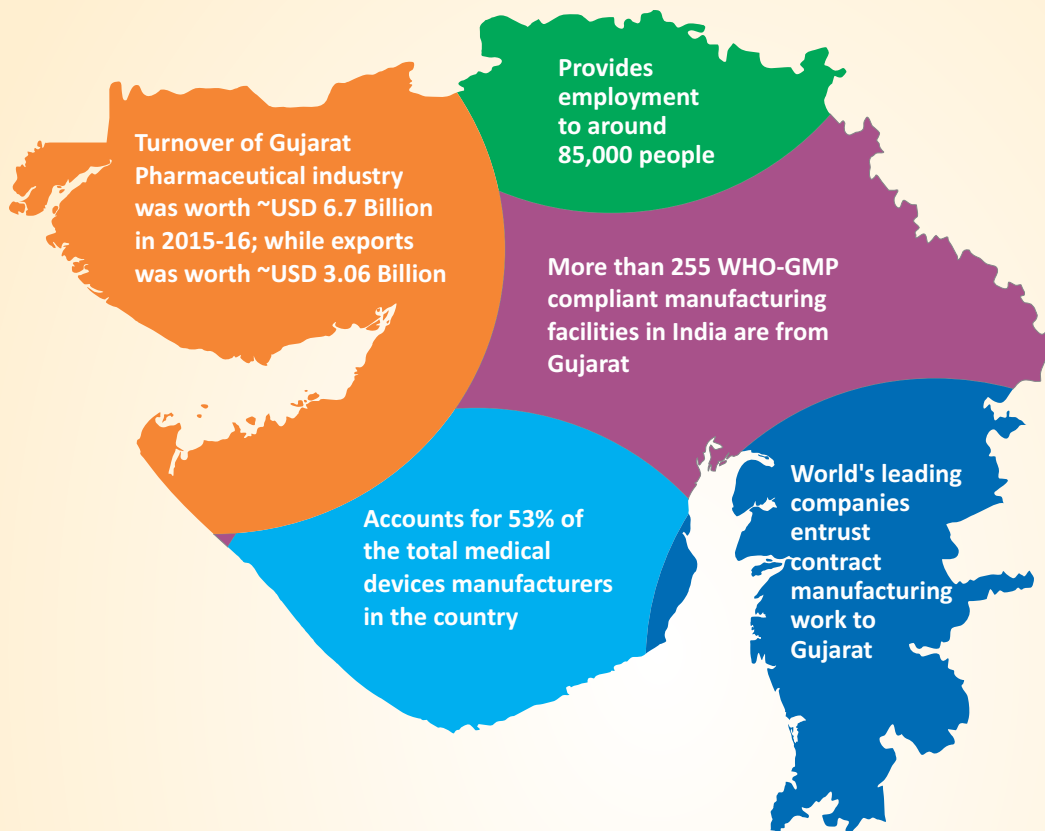
- Indian pharmaceutical sector accounts for about 2.4% of the global pharmaceutical industry in value terms and 10% in volume terms
- The sector increased at a CAGR of ~13% over 10 year period and is expected to grow at a CAGR of ~22% to reach USD 55 billion by 2020 (from 2015)
- By 2020, India is expected to be 6 th largest market globally
- Leader in exports: Exported products worth USD 15 billion in FY15 and exports are expected to reach USD 40 billion by 2020
- India accounts for 20% of global exports in generics, largest provider of generic medicines globally
- Attracted FDI worth USD 13.5 billion during January 2000 to December 2015 (5% of total FDI)
